

NC Senior Tar Heel Legislature Appoints Gayla Woody as Delegate for Gaston County

April 1, 2022 – Raleigh, NC

At its first General Session of 2022, the North Carolina Senior Tar Heel Legislature recognized local resident Gayla Woody as delegate for Gaston County.

Woody is a retired professional who served in the field of aging for over thirty years. She was the director of Centralina Area Agency on Aging for thirteen years after working with the area agency and the Gaston County Department of Aging. She holds a Bachelor's of Education from Florida State University and a Master's of Education from Presbyterian School of Christian Education. Woody was certified as a director of Christian Education and worked in the field for about five years.

Woody says, "I am very excited to have the opportunity to work in advocacy for older adults." Working for many years in advocacy with Centralina Area Agency on Aging, Woody also served over eight years on the board of the National Association of Area Agencies on Aging. As an advocate on the national level, she spoke before the US Senate's Committee on Aging. She also served over ten years on the Southeastern Association of Area Agencies on Aging. As a NC representative, she worked with seven other states coordinating advocacy efforts on the behalf of older adults.

"I am so honored", says Woody, "to have been awarded the NC Order of the Long Leaf Pine in recognition of my work with older adults. There is much work to be done on behalf of older adults and I look forward to continuing this work with the NC Senior Tar Heel Legislature."

Linda Miller, Director of Centralina Area Agency on Aging, says "Woody's appointment to NC STHL gives her a renewed opportunity to continue her advocacy on behalf of older adults in Gaston County.
